## **MARGARET S. LEE BATTLE OF SEXES BOOK SCHOLARSHIP APPLICATION**

### **INTRODUCTION**

The Margaret S. Lee Battle of the Sexes (MSLBOS) Tournament Committee offers book scholarships to students enrolled in college. The purpose is to provide some financial assistance to undergraduate college students who are bowlers and active with their local senates.

The number of scholarships and amounts will be based on the Margaret S. Lee Battle of the Sexes tournament proceeds, therefore the number and scholarship amounts awarded will be determined by the MSLBOS Tournament Committees annually.

### **OPERATIONS & PROCEDURES**

1. The National Scholarship Chairperson will furnish scholarship applications to the Local Senates' Scholarship Chairpersons. Applications are to be provided to qualified college students who have continued to be active in TNBA through bowling, volunteering, and/or other actions.
2. Eligibility is restricted to students who are members of The National Bowling Association, Inc. and are currently in college. **(Recipients of the Owen O. Washington Scholarship are NOT eligible to apply until their sophomore year.)**
3. Any member of The National Bowling Association, Inc. may nominate an eligible college student who is a TNBA member from their local senate.
4. The application along with the student's current college transcript must be submitted to the Local Senate Scholarship Chairperson by October 31 (current freshmen must submit transcript as soon as possible). All applicants will have to provide proof of enrollment for the second semester.
5. The Local Senate Scholarship Chairperson will verify the students' activities within the senate and forward completed applications to the National Scholarship Chairperson by November 30.
6. It is the committee's goal to provide assistance to students by the start of the midterm. Therefore adhering to deadlines is essential.
7. The MSLBOS and the National Scholarship Chair will evaluate the applications to make the final decision on the winners. They also reserve the right to interpret and apply the intent of the provisions of this scholarship application.
