2. Anyone may nominate, in writing, a current or former member for consideration in the Hall of Fame in the Meritorious Service and Sponsorship Category. It is the responsibility of the Nominator, and Nominee, unless deceased to provide verification of all submitted information.
3. All TNBA National Hall of Fame Nomination Fact Sheets must be typed or neatly printed.
4. All completed Meritorious Service and Sponsorship Nomination Fact Sheets must be received and or postmarked by the TNBA National Hall of Fame Chairperson by December 1st.
5. All Meritorious Service and Sponsorship Nomination Fact Sheets will be evaluated by the TNBA National Hall of Fame Committee on the following categories:
 - A. Attending a minimum of ten (10) TNBA National Conventions,
 - B. TNBA Service (Offices held, Directorships, Chairmanships, Committees served, volunteer work, etc. on the national, regional, and local levels,
 - C. Other Bowling Organization Service on the national, regional, and local levels,
 - D. Certified Bowling Instructor, Certified Bowling Coach and/or Volunteer Coach Service,
 - E. Special Accolades, Awards, and Honors on the national, regional, and local levels,
 - F. Additional Contributions to TNBA on the national, regional, and local levels, and
 - G. Clarity and Completeness of Meritorious Service and or Sponsorship Nomination Fact Sheet.
6. Elected Meritorious Service and Sponsorship Member(s) will be inducted into the TNBA National Hall of Fame during the Hall of Fame Induction and Annual Awards Banquet in May.
