

## MIXED DOUBLES SCRATCH (Man & Woman)

- 1. Eligibility: All 2023-2024 TNBA members as defined by TNBA and who are certified by USBC.
- 2. Entries close March 15, 2023 at 7:00 PM (Last Squad). Reserved entries must be accompanied by a certified check or money order. No entry will be accepted if the application is not fully completed. Walk-ins will be accepted, if spots are available before the start of any of the squads. (NO PERSONAL CHECKS WILL BE ACCEPTED).
- Unattached cards USBC-\$24.00, TNBA \$30.00 Must show cards prior to bowling.
- 4. Tournament Format Four (4) games across eight (8) lanes.
- 5. Prize fund will be paid 100%. Prize ratio will be at least one (1) prize for every five (5) entries.
- 6. Current or past PBA members <u>will be</u> permitted to bowl in TNBA tournaments if they have not achieved the following: (a) top 40 on PBA tour money or point list in the past three years; (b) won a PBA tour title in past seven years; c) top 20 on PBA Regional tour money or point list; (d) won a PBA Regional tour title in past four years. PBA50 and WPBA members <u>will be</u> permitted to bowl providing they have not achieved the following: (a) top 20 on PBA50/WPBA tour money or point list in the past two years; (b) won a PBA50/WPBA tour title in past four years; c) top 10 on PBA50/WPBA Regional tour money or point list; (d) won a PBA Regional tour title in past two years.
- 7. Premature termination of the tournament brought about by war, national emergency or emergency causes relating thereto or there from; fires, strikes, lockouts, labor difficulties or other reasons beyond the control of the Bill Rhodman Classic, shall cause the foregoing prize schedules to be prorated in accordance with the number of entrants who have bowled.
